LOCAL TASK FORCE Fact Sheet





What is Local Task Force (LTF)?

LTF is a committee of parents, consumers, and representatives that works to ensure children with disabilities receive the services and support they need. LTF's are active across Pennsylvania, and they follow procedures outlined by the State Task Force.

How did the LTF begin?

The LTF system was established in 1972. The PARC Consent Decree mandated the establishment of an LTF in each of the 29 Intermediate Units in Pennsylvania. The purpose of the LTF was to ensure that the spirit of the Consent Decree was carried out. The LTF's were formed to advocate for the needs of students with intellectual disabilities and their families.

What is the PARC Consent Decree?

The PARC Consent Decree was a court order in 1972 that established the right of children with intellectual disabilities to receive a free public education. The decree was the result of the lawsuit Pennsylvania Association for Retarded Citizens (PARC) v. Commonwealth of Pennsylvania

What is the process when addressing concerns?

LTF refers systemic issues identified locally to the appropriate IU, LEA, local agency, Bureau of Special Education Advisor, or to the State Task Force chairperson for clarification, recommendation, or solution.

Parent Scholarships

Parent members of the LTF have the opportunity to apply for a scholarship to attend the PDE or Autism Conference

LTF works to:

- Provide information and support to parents of children with disabilities
- Propose recommendations to improve services for children with special needs
- Share information and network with the community
- Address individual issues brought to the committee by parents
- Monitor programs and services for people covered under Intellectual Disabilities Services
- Cooperate with public and private service provider agencies
- Refer problems to LEAs, approved private agencies, or the State Task Force
- Make recommendations to the State Task
 Force or other approved private groups
